History and Context


EUROPEAN CONVENTION ON HUMAN RIGHTS (1951)

- Article 3: States are prohibited from returning individuals to countries where they would face a real risk of torture, inhuman or degrading treatment - *refoulement*
- Resulting issues with returning asylum seekers whose applications have been turned down, but their country of origin is unsafe
- Processing asylum seekers abroad is permissible, but there are obligations upon the transferring country regarding the welfare of the asylum seekers

BREXIT

- End to refugee agreements with European Union
- Asylum case backlog increase
- Increase in non-European immigration (small boats)

Small Boats and Net Migration




UK Net Migration



The Rwanda Scheme

- UK Gov signed a five-year, £140 million agreement with Rwanda to send some of the UK's asylum seekers there to have their claims processed
- If their claim is successful, they could be granted refugee status and allowed to stay. If not, they could apply to settle in Rwanda on other grounds, or seek asylum in another "safe third country".
- No asylum seeker would be able to apply to return to the UK
- At present, no asylum seekers have yet been sent there.

The Rwanda Scheme

ISSUES WITH IMPLEMENTATION

- Rwanda scheme ruled **unlawful** by the UK Supreme Court in November 2023 due to 'serious and systemic defects in Rwanda's institutions and procedures for processing asylum claims'
- Concern of genuine refugees sent there being later sent back to their home countries potentially harmful
- Human rights record of Rwanda 1994 genocide
- Overstrained immigration system
- In 2021, the UK government had itself criticised Rwanda for its "extrajudicial killings, deaths in custody, enforced disappearances and torture".
- Incident where Rwandan police opened fire on protesting refugees

UK-Rwanda Treaty

- Signed in December 2023
- Provides guarantees and protections not in the original MoU
- Relocated individuals cannot be removed by Rwanda to any country except the UK – addresses refoulement
- Enables the UK to request the return of anyone removed to Rwanda
- Independent monitoring committee to be put in place

IS RWANDA A 'SAFE' COUNTRY?

- Existing issue still remains regarding whether or not Rwanda is a safe country
- Treaty contradicts this government's own Illegal Migration Act - once removed from the UK to safe third country, they cannot be returned

Safety of Rwanda (Asylum and Immigration) Bill CONTENTS ISSUES

- Intended by the UK government
 to be a solution to the legal
 blockages to the Rwanda
 Scheme
- 'Every decision-maker must
 conclusively treat the Republic
 of Rwanda as a safe country'.
- Disapplication of the Human
 Rights Act 1998

- Violation of International Law government minister unable to provide (conventional) assurance of compliance
- Dangerous undermines the courts
- Sets a precedent of a government overruling the courts
 problematic when it comes to courts ruling on the legality of Government decisions
- Parliamentary sovereignty
- House of Lords

State of the Rwanda Bill

- Has passed 3rd reading in the House of Commons
- Currently in the Committee stage in the House of Lords
- Conservatives do not have a majority in the House of Lords
- They can block bills for up to two years


WHAT NEXT?
